Defining the Problem: Who Responds to Youth Experiencing a Crisis



Youth are experiencing an urgent mental health crisis.




There is an increased number of youth hospitalized for behavioral health reasons.



Juvenile justice systems report that youth have significant behavioral health needs.



How we respond to youth's health needs impacts outcomes.







Policy and Practice Responses: New Approaches to Meet Youth's Health Needs in the Community

Establishing alternative first response options can create meaningful and long-term positive outcomes for safety and stability for youth and the community.


Diversion policies can help keep youth in school and the community and out of the justice system for low-level offenses that are rooted in family conflict and behavioral health needs.

These new approaches also directly respond to youth's issues as health concerns rather than as public safety issues.





Policy and Practice Responses: Advancing Equity and Power Sharing







States in Action: Alternative Response Models

<u>Massachusetts</u>: Mobile Crisis Intervention maintains a 24/7 hotline for children and families, conducts assessments, and coordinates care among a range of providers and community organizations. The <u>School Mental Health</u> <u>Consortium</u> provides comprehensive mental health services, supports, and responses to students.

<u>Nevada</u>: Children's Rural Mobile Crisis Response Team partners with detention centers, schools, and hospitals to provide telehealth crisis supports and aftercare.

<u>New Jersey</u>: Mobile Response and Stabilization Services are for youth under 21 years old experiencing a crisis. Family members and professionals can request immediate stabilization services 24/7 from a clinician; up to eight weeks of follow-up are included.

Oklahoma: Youth Crisis Mobile Response supports community stabilization with youth up to 25 years old by providing crisis services and follow-up after the event via teams made up of peers and paraprofessionals with deep community ties.

Wisconsin: The state's School Mental Health Framework includes a range of components to build and sustain school mental health systems and support youth in schools with trained professionals.





Free Technical Assistance Opportunity!

Goal

 Partner with two jurisdictions to provide cost-free, intensive technical assistance for nine months to develop a diversion initiative focused on alternative responses to law enforcement contact for youth who are experiencing a behavioral health crisis.

Expected Outcomes

- Outlined model components, partnerships, and funding for the diversion initiative
- Identified policies and procedures to support implementation, drafted new policies, and gained buy-in for changing these policies
- Developed a detailed action plan that outlines the diversion initiative components and policies, timelines, roles and responsibilities, and tools to gain additional buy-in and fundraise





Free Technical Assistance Opportunity!

Site Requirements

- Form an internal agency working group chaired by an agency leader.
- Readily share data, policies, and practices concerning law enforcement contact, behavioral health needs, juvenile court referrals, school discipline, diversion initiatives, and more.
- Demonstrate a clear commitment to meaningful policy and practice change by developing a detailed action plan for reform and an ongoing forum for overseeing this work.
