

## **Medicaid Renewals**

- Help eligible individuals in your state maintain health coverage.
- Local and state corrections facilities have a unique role in ensuring that people leaving correctional facilities have health care coverage.
  - $\circ$  Assist eligible beneficiaries during reentry with renewals and education about the renewal process.
  - Use visitor rooms and other public spaces in your facilities to provide Medicaid renewal information for families and other visitors.
