








Stepping Up Timeline




Overrepresentation of SMI in Jails





Judges and Psychiatrists Leadership Initiative

- Aim to train over 10,000 judges and 2,500 psychiatrists by 2030

NGA Upcoming Work (2024)

- NGA has identified states that will participate in the aforementioned policy academies and learning collaboratives.
- Participating states will receive technical assistance and support for their state goals.
- States will convene in person and virtually to share best practices.







Vera Institute of Justice—Current Efforts

- In New Orleans, Vera's Redefining Public Safety team worked with the City of New Orleans Department of Health to develop an alternative dispatch model that would deploy a community-centered crisis response team to assist a person experiencing a mental health crisis or a drug overdose.
 - City of New Orleans launched the Mobile Crisis Intervention Unit (MCIU), which responds to 911 calls involving a mental health crisis
 - Establishment of a Community Advisory Board (CAB) to promote community education around the MCIU
- Tarrant County, Texas, is the largest county in the U.S. without a public defender's office. Together with United Fort Worth, Vera's Beyond Jails Initiative is working to change that.
 - 75 percent of clients have a mental health diagnosis or have their competency to stand trial raised

- In 2024, we will work in multiple jurisdictions to build equitable, sustainable diversion programs over the next year including to expand restorative justice, divert felon-in-possession gun charges, and build alternatives so that people experiencing mental health crises are not jailed as a result.





Update on the Prison Research and Innovation Initiative

- Since 2019, the Urban Institute has been leading the Prison Research and Innovation Initiative, funded by Arnold Ventures.
- This comprehensive, six-year effort seeks to understand prison conditions and pilot innovative strategies to make prison conditions more humane, safe, and rehabilitative both for people who are incarcerated and those who work in them.
- Some states have examined how the mental health and well-being of corrections staff compare to the mental health and well-being of incarcerated individuals.







Update on Findings from the Evaluation of Durham's Misdemeanor Diversion Program (MDP)

- 1. The majority of people eligible for the MDP were not referred to the program while it was operational from March 2014 to November 2019.
- 2. Of those who did participate in the program, there was a very high completion rate of 95 percent.
- 3. MDP participants had significantly lower rates of rearrests, convictions, or jail admissions than comparison groups after six months, one year, and two years.

- 4. Participation in the MDP significantly reduced disparity levels of new arrests within two years—and new convictions and jail admissions within six months—for Black people compared to people of other races.
- 5. The MDP did not have a larger impact on overall arrest, conviction, or jail admission levels for the two age groups in the county.





Upcoming Project: Prevalence Estimation of Co-occurring Mental Health and Substance Use Disorders in Residential Juvenile Justice Facilities

With funding from NIJ, we will be partnering with multiple state and local juvenile justice agencies to accurately estimate the prevalence of cooccurring mental health and substance use disorders (COD) for youth in residential juvenile justice facilities and examine disparities in diagnoses by race and ethnicity. To determine the prevalence of CODs, Urban will gather comprehensive data on the entire residential youth population in each agency, prioritizing similar assessment processes and the same diagnostic codes across sites.





Upcoming Project: Comprehensive Opioid, Stimulant, and Substance Use Program TTA on Pretrial, Prosecution, Defense Counsel, and Courts

With BJA funding, and in support of RTI, we will provide TTA to develop comprehensive strategies to respond to the overdose crisis and the impacts of opioid, stimulant, and other substance use and misuse on individuals and families as a TTA provider to COSSUP (Category 2) grantees.
