Consolidated Appropriations Act of 2024 (CAA)

- Medicaid and CHIP Eligibility and Access
 - CAA legislation prevents termination of Medicaid due to incarceration, ensuring continuous care by January 2026
 - Centers for Medicaid and Medicare Services (CMS) is able to award \$113.5 million in planning grants to states
 - CMS will issue guidance on best practices and how to help promote continuity of care



Consolidated Appropriations Act of 2023 (CAA)

- Requirements under Sections 5121 and 5122
 - A Medicaid-eligible individual who is under 21 years of age
 - An individual between the ages of 18 and 26 who is eligible for Medicaid under the mandatory former foster care children group
 - Mandatory coverage of pre-release health services and 30+ days post-release case management
 - Optional coverage for youth with pending charges, encouraging early support



Consolidated Appropriations Act of 2023 (CAA)

- Implementation and Compliance
 - States encouraged to collaborate with carceral and community health providers to deliver required services
 - Enhanced federal financial participation (FFP) is available for IT system improvements to support data sharing and agency coordination
 - Deadline: States have until January 1, 2025, to implement the changes
 - Impacts juvenile and adult correctional facilities
